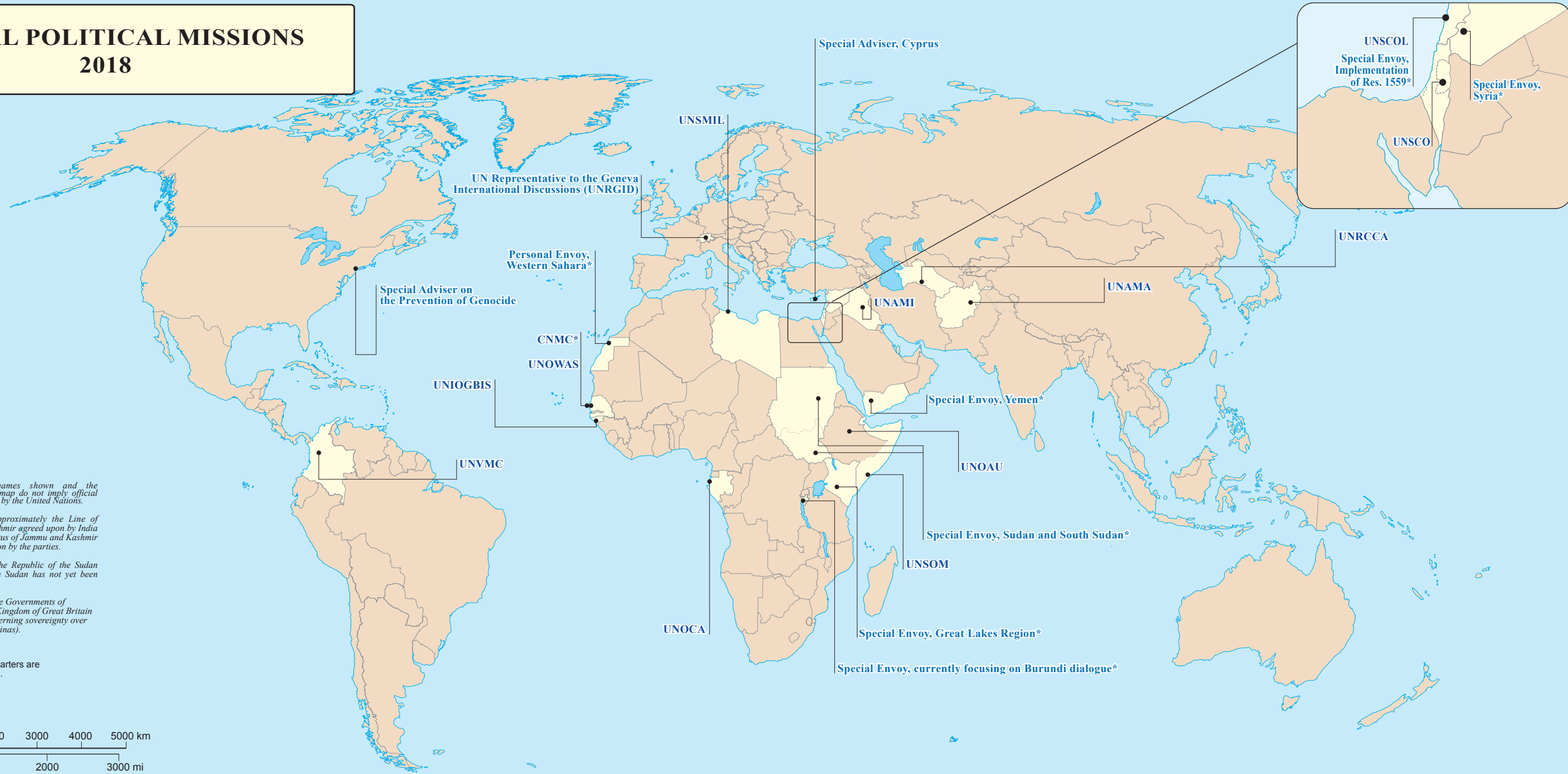
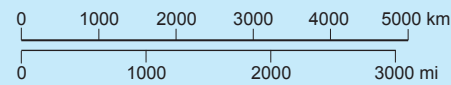
The boundaries and names shown and the designations used on this map do not imply official endorsement or acceptance by the United Nations.
